## **BUSINESS**

### *Financial Guidelines Discussion*

Student Government discussed potential edits to the Financial Guidelines. The focus was on clarifying certain sections to mitigate confusion.

Members discussed the “reasonable” standard outlined in the guidelines. It is necessary to have some ambiguity to allow for exceptions and discretionary spending by the committee, depending on clubs’ needs and funding availability.

### *Financial Guidelines Vote*

President Brown motioned to approve the new financial guidelines. Representative Maheras seconded the motion, and it passed unanimously.

### *Delegate Resolution Proposal*

Initiative to delegate a proportional number of students from each category of clubs to attend a monthly Stu Gov meeting, as well as act as a liaison between Stu Gov and the clubs. This proposal seeks to bridge the gap between student organizations and Student Government, ensuring more effective communication and engagement.
