BUSINESS

Introduction to Campus Recreation

Jody Frey, Director of Recreation Services, and Kris DeJesus, Associate Director of Organized Sports (Intramurals and Sport Clubs), introduced themselves to the General Body.

Jody Frey discussed the facilities-related responsibilities of her role and reported that the Recreation Department has published a summary report on sport clubs. Copies of the report were provided for the Executive Board. The report presents a high-level overview of sport club activity, including the number of clubs recognized by the department at the beginning and end of the semester. Sport clubs not recognized by Student Government are likewise not recognized by the Recreation Department. This semester began with 33 recognized sport clubs and concluded with 29.

Recognition requires attendance at a SCORE workshop by two club officers. These workshops outline mandatory deadlines and required organizational standards for sport clubs. Clubs that fail to attend a SCORE workshop are not eligible for recognition. For the current semester, there are 33 sport clubs, 32 of which are currently recognized. Clubs have until February 13 to complete all recognition requirements. Sport clubs that fail to achieve recognition for two consecutive semesters are dissolved and must seek re-approval through Student Government to be reinstated.

Jody Frey and Kris DeJesus also reviewed the role of safety officers within sport clubs, including CPR certification requirements and the number of safety officers required based on each club's assessed risk level.

They emphasized the importance of collaboration between student organizations and the Recreation Department, noting the department's detailed understanding of the operations of each sport organization. Additionally, they discussed the potential transition of sport club coaches to Lafayette College's payroll, which would formally integrate coaches into the Lafayette community. At present, coaches are not considered members of the Lafayette community and do not have Lafayette College email addresses.

Preface to Constitutional Changes

All Student Government members filled out a 3-page questionnaire/test on the constitution and financial guidelines. The purpose of this was to check in with all members, and ensure that everyone is on the same page in regards to the Constitution, and thereafter following it going forward.

Google Drive Walkthrough

Vice President Hooey rearranged the shared Student Government Google Drive to increase organization, and accessibility. She walked the General Body slide-by-slide through the folder, and how it is now organized.

Committee Planning

Each Committee that met filled out an Action Plan-Setting worksheet where they assessed the purpose of their committee, goals, resources needed, challenges, etc. Each committee's respective document can be found in their Google Drive folder.

Representative Hannah Cohen announced that CHTI, a group she's a part of, is hosting the President of the Stanford Human Trafficking Lab on Feb 23rd. More details to come!

ANNOUNCEMENTS

President Waxman thanked everyone for their flexibility in adjusting to their new committees. Committee chairs will be invited to the Exec meeting next week.

President Waxman and Representative Will Bennett met with the Associate Provost of Curriculum because Lafayette is soon applying to become re-accredited. There's going to be an event towards the end of March that they would love to have student representation at. President Waxman will reach out to the General Body closer to the event with timing. Representative William Bennett added on about the importance of the reaccreditation, and the role in which Student Government could have in it.

Treasurer Vale motioned to enter executive session. It was seconded by Inclusivity Officer Ibrahim and unanimously approved.

Inclusivity Officer Ibrahim motioned to exit executive session. It was seconded by Treasurer Vale and unanimously approved.
