Role of Committee Heads:

- Organize meetings, communicate with other members, facilitate the completion of projects, delegate tasks, report back to exec and larger GB.

Committees:

- Academic Affairs
 - Focuses on academic aspects of Lafayette College. Responsible for the administration of the Student Government superior teaching award.
- Budgets
 - Head: Gracie Vale
 - Reviews student organization budget requests and recommends budget allocations to the Student Government General Body pursuant to the Student Government Budget Guidelines. The committee is co-chaired by the Treasurer and the Chair of the Standing Committee on Student Organizations.
- Communications
 - Head: Hayden Cohen
 - The Standing Committee on Communications initiates and develops a regular program to publicize actions of the Student Government and concerns to the campus. It facilitates the Student Government's relations with the College's Communications Division. The Committee is chaired by the Communications Officer.
- DEI
 - Head: Evalina Ibrahim
 - The Standing Committee on Equity & Inclusion serves as a liaison between the Student Government and intercultural organizations, coordinates programming efforts with the Office of Intercultural Development, and examines and explores opportunities to improve inclusivity on campus.
- Student Life
 - The Standing Committee on Student Life oversees the broadest set of responsibilities of all the committees. It collaborates with Bailey's Health Center, Dining Operations, Information Technology Services, the Library, Housing, and the shuttle operations to ensure that student feedback is appropriately heard and accommodated by all of the various student services offered by the College. It additionally liaises between the Student Government and Greek life organizations. The Inclusivity Officer serves as a member of the Committee.

- Student Organizations
 - The Student Organizations Committee supervises students through the process of forming new clubs, advises existing groups, and works with the budget committee to best determine how to financially support student organizations. It also ensures that the constitutions of all student organizations uphold basic College policy.
- Sustainability
 - The Standing Committee on Sustainability promotes the environmental sustainability of Lafayette, through coordinated programming efforts with the Office of Sustainability or advising student organizations and the College's operations.
- Dining Ad-hoc
 - The Dining Ad-Hoc meets with dining faculty every other week to discuss possible improvements, issues brought up by students, and promoting dining initiatives.
- Pard-pantry Ad-hoc
 - The Pard Pantry, operating from the Leopard's Lair, is dedicated to providing non-perishable food items and personal hygiene products to students at Lafayette College. Committee work including ordering, restocking, and opening the pantry on a weekly basis. Primary usage of the pantry is over breaks so communication between members and Ally is crucial.
- Financial Guidelines Ad-hoc
 - The Financial Guidelines Rewrite Committee was created in order to review the current budget's financial guidelines with the goal of refining them to make an improvised version
- Constitutional Rewrite ad-hoc
 - The Constitutional Rewrite Ad-Hoc this semester is comprised of people who are taking a look at our Constitution and reevaluating it. This Ad-Hoc worked in hope of improving our Constitution which in turn improved Student Government's influence on campus.

OPEN FLOOR

Non-voting member Hannah Cohen announced her participation in the Strategic Plan Implementation Advisory committee, and provided herself along with Emerson Casper as a resource for Student Government members to give them feedback on campus life that they can take directly to administration.
